## REFUND POLICY

The refund schedule applies in cases of withdrawal from the University as well as in cases of reduction in the number of registered units during a quarter. For refund purposes, a week of classes refers to a calendar week beginning with the first day of classes -- holidays not considered. The effective date for determining a refund is the date the Registrar receives written notification of a drop or withdrawal from the student. Students have a right to full refund from all tuition charges if they notify the University in writing, and the written notification is received prior to or by the last day of the official first week of instruction. The University's refund policy for students who have completed 60% or less of the new course of instruction shall be a prorated refund. If the University cancels or discontinues a course, the University will make a full refund of all associated tuition charges. If the student drops the course in the third through the sixth week, a late drop fee of \$100 or 5% of the tuition, whichever is less, shall be charged. Refunds will be paid within 30 days of receipt of notification of cancellation or withdrawal. The refund shall be the amount charged for instruction multiplied by a fraction, the numerator of which is the number of hours which the student has not received but for which the student has been charged, and the denominator of which is the total hours of instruction for which the student has been charged.
